

PRODUCT USE GUIDE FOR PURPLE BEER LINE CLEANER K33

Product Description

A powerful blend of caustic alkalis and chlorine based bleaching agent. Also contains a colour indicator to signify when the product is exhausted.

Product Features

- Concentrated and highly effective cleaner for the maintenance of beer lines.

Direction for Use

- Add 50ml product to 5 litres cold water. Thoroughly mix cleaning solution in a brewery approved cleaning container.
- Drain beer from system.
- Fill system with cleaning solution ensuring any remaining beer is forced out.
- Leave system to soak for at least 30 minutes.
- The resulting dirty-green solution is pulled through the pipes. This should then be replaced by more purple solution.
- The second solution is then left for a few minutes. If it remains purple the lines are sterile. If green repeat 1-5 above.
- Flush plenty of cold water through system to ensure all traces of solution are removed.
- Refill system with beer.
- **Not for use in brass beer engines.**
- **Use only in diluted form according to instructions.**
- **Use only in cleaning containers supplied by the brewery.**
- **Use fresh solution every time - do not store in diluted form.**
- **Draw solution through the pipe-work. Rinse the line with clean water before re-use.**

Correct use of this method each week will ensure pipes and equipment are maintained in a hygienic condition.

Storage

- Store in cool conditions away from direct sources of heat
- Avoid extremes of temperature
- Do not allow to freeze
- Ensure the cap is tightly fitted after use
- Keep out of reach of children
